If we don't enact polices that support the housing industry or eliminate/reduce regulations that prohibit growth, the housing industry will suffer and impact communities.

What is your philosophy on residential development, impact fees, property taxes, etc.?

The key to any community's long-term growth and prosperity is its ability to attract and build its residential development. As generations change, their tastes in housing stock changes and communities need to be aware and adapt to those changes. I am a firm believer that keeping property taxes low is a key component in either keeping people in the community and the potential to attract additional families into the community which in terms lends itself well to new home construction and residential remodeling as people look to remain in the community for a long time. As it relates to impact fees, I believe one has to look carefully at what the fees are being used for and if those fees drive up the price of home construction considerably thereby making it not worth the investment. Again, I am for less regulations and impact fees can be used in this manner which is counterproductive in either bringing new growth to the community.

What else can be done to encourage and support new housing development?

Seeing firsthand the struggles that my communities have encountered in attracting new housing developments, we must engage with not only our local govt. entities (townships/municipalities) but also our state govt. to promote policies the encourage deregulation and/or revised ordinances that will encourage and promote housing development or remodeling. Keeping informed on the emerging issues within the industry is key and utilizing organizations such as the HBA will prove pivotal moving forward.

What is your position on the rights of property owners with regard to development, redevelopment and remodeling?

I believe that the property owner has the right to make improvements to their property, such as erecting buildings etc. without overburdensome limitations regarding the size, configuration and use of real property ("zoning laws"), and ordinances which control both the way the construction is to performed and the minimum standards the buildings must comply with ("building codes"). Many local units of government have made it very difficult to pursue development etc. without "jumping through hoops" with regulations and fees. In many cases this deters many from pursuing due to the long lead times and excessive fees/regulations.
